## **SHARE ACCOUNT FEES**

- IRA Share Account Transfer  
to another Institution:..... \$25 per transfer

## **SHARE DRAFT CHECKING ACCOUNT FEES**

- Check Printing:..... Prices vary based on style and checking account type. Fee waived for members age 60 and older (standard orders only.) Shipping charges apply.
- Transfer Fee from Regular Share Account or Overdraft Line of Credit:..... \$10 per transaction
- Second Chance Checking
  - Service Fee:..... \$15 per month
  - Debit Card Fee:..... \$10 per year

### **Monthly Checking Fees**

- Unbank Checking:..... None
- Ultra Checking:..... \$3  
(Fee waived with full direct deposit or \$100 minimum balance)
- Your Choice Checking:..... \$8.99  
(Fee waived with full direct deposit)

- Copy of Official Check Fee:..... \$5 per item

- International Deposit Fee:..... \$10 per item
- ATM/Debit Card Replacement Fee:... \$10 per card
- ATM/Mobile Incorrect Deposit Fee:... \$2 per deposit

(any check under \$500)
- Inactive Account Fee:..... \$5 per month (after 6 months  
(Regular Share Account) and account balance under \$50)
- Duplicate Release of Mortgage Fee:... \$35
- Bad Address Fee:..... \$2.50 per month
- Paper Statement Fee:..... \$2 per statement  
(Ages 17 and younger and 60 and older are exempt. Does not include Home Loan statements)
- Share to Share Transfer  
through Call Center..... \$2 per transfer

## ATM WITHDRAWAL FEE

- Connex ATMs:..... Free
- Non-Connex ATMs:..... 7 free per month, then \$2 per withdrawal (Allpoint is a non-Connex ATM)

## HEALTH SAVINGS ACCOUNT FEE

- Administrative Fee to Close Account:.....\$25

## STOP PAYMENT FEE

- Includes: Share Draft Checking, ACH Origination, Official Check, Bill Payment Merchant Processor, Popmoney/Funds Transfer .....\$35 per item

## PAY-BY-PHONE FEES

- Loan Payment Amount:
  - \$50-\$200 .....\$15 per transaction
  - \$201-\$500 .....\$20 per transaction
  - \$501-\$750 .....\$30 per transaction
  - \$751-\$1,500 .....\$35 per transaction
  - \$1,501 and higher .....3% of payment amount

- Online Banking via Internet: ..... Free
- Online Bill Payment:..... 10 bills per month **with Free Checking** (\$0.30 per bill after 10)

***Unlimited Online Bill Payment with Ultra Checking, Your Choice Checking, Unbank Checking and Second Chance Checking***

- Expedited Popmoney/Funds Transfer Service:.....\$3 per item

## NON-SUFFICIENT FUNDS FEE (NSF) PAID/RETURNED

- Includes: Share Draft Checking, ATM/Debit Card, Automatic Debit (includes Popmoney and External Transfers), Bill Payment Connex, Bill Payment Merchant Processor .....\$35 per item
- Overdrafts: Extended Overdrawn Balance Fee (Applies to accounts overdrawn for 5 consecutive business days. Fee applied on the 6th business day) .....\$35

## LOAN FEES

- Loan Coupon Book Fee:.....\$10 each
- Skip-a-Payment Fee (one per year)..... \$25 per request

## CREDIT UNION MEMBERSHIP

- Membership Share:.....\$25 par value
